### **Please read Completely and Carefully Before Signing**

I accept full and complete responsibility for all medical and associated expenses (including transportation to and from any medical facility) that my Child incurs while participating in I Dig Q&D and shall indemnify, defend and hold harmless the Released Parties, and all of them, for any such costs and expenses.
